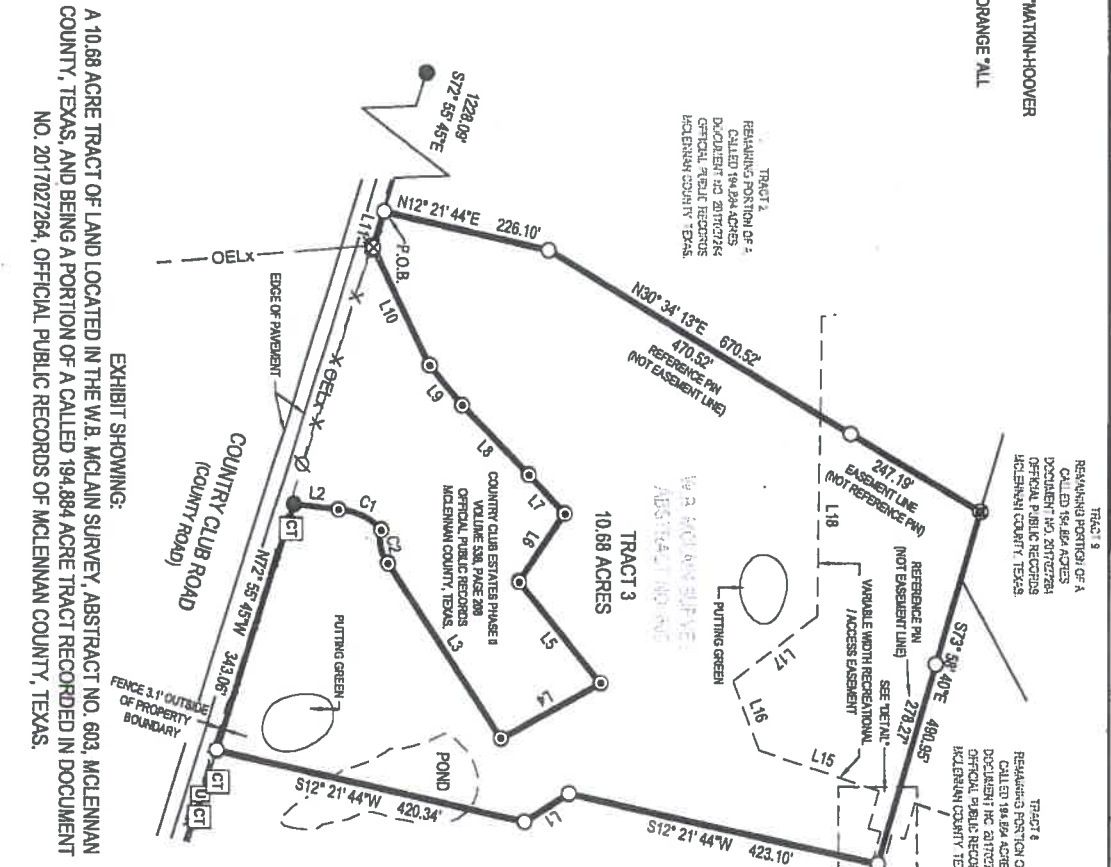

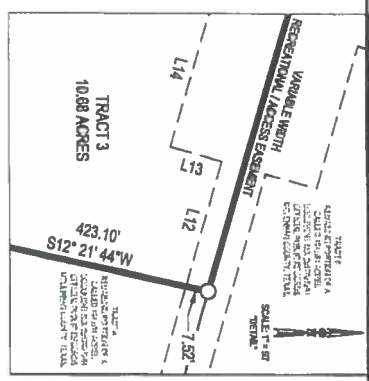

A 10.68 ACRE TRACT OF LAND LOCATED IN THE W.B. MCLAIN SURVEY, ABSTRACT NO. 603, MCLENNAN COUNTY, TEXAS, AND BEING A PORTION OF A CALLED 194.884 ACRE TRACT RECORDED IN DOCUMENT NO. 2017027264, OFFICIAL PUBLIC RECORDS OF MCLENNAN COUNTY, TEXAS, SAID 10.68 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:


Beginning at a 1/2" iron rod with a red "Matkin-Hoover Eng. & Survey" plastic cap set in the northeast right-of-way line of Country Club Road, the southwest boundary line of the called 194.884 acre tract, said point bears S 72° 55' 45" E, a distance of 1228.09' from a 1/2" iron rod found at the southeast end of a cutback line at the intersection of the northeast right-of-way line of Country Club Road, with the southeast right-of-way line of Blue Cut Road South, and an angle in the southwest boundary line of the called 194.884 acre tract,;

(1) Thence, departing the northeast right-of-way line of Country Club Road, the southwest boundary line of the called 194.884 acre tract, with the northwest, northeast and southeast boundary lines of the herein described tract, severing the called 194.884 acre tract, the following courses and distances:

- a. N 12° 21' 44" E, 226.10' to a 1/2" iron rod with a red "Matkin-Hoover Eng. & Survey" plastic cap set for angle;
- b. N 30° 34' 13" E, at distance of 470.52' passing a 1/2" iron rod with a red "Matkin-Hoover Eng. & Survey" plastic cap set for a reference point, continuing a total distance of 670.52' to a calculated point for corner;
- c. S 73° 58' 40" E, at distance of 212.68' passing a 1/2" iron rod with a red "Matkin-Hoover Eng. & Survey" plastic cap set for a reference point, continuing a total distance of 490.95' to a 1/2" iron rod with a red "Matkin-Hoover Eng. & Survey" plastic cap set for corner;
- d. S 12° 21' 44" W, 423.10' to a 1/2" iron rod with a red "Matkin-Hoover Eng. & Survey" plastic cap set for angle;
- e. S 32° 38' 16" E, 70.71' to a 1/2" iron rod with a red "Matkin-Hoover Eng. & Survey" plastic cap set for angle;

- f. S 12° 21' 44" W, 420.34' to a ½" iron rod with a red "Matkin-Hoover Eng. & Survey" plastic cap set for corner in the northeast right-of-way line of Country Club Road, the southwest boundary line of the called 194.884 acre tract;
- (2) Thence, N 72° 55' 45" W, with the northeast right-of-way line of Country Club Road, the southwest boundary line of the called 194.884 acre tract, a distance of 343.06' to a ½" iron rod found for corner at the south corner of Country Club Estates, Phase 2, recorded in Volume 538, Page 208, Official Public Records of McLennan County, Texas, and an angle in the southwest boundary line of the called 194.884 acre tract;
- (3) Thence, departing the northeast right-of-way line of Country Club Road, with the southwesterly and northwesterly boundary lines of Country Club Estates, Phase 2, the northwesterly and southwesterly boundary lines of the called 194.884 acre tract, the northwesterly and southwesterly boundary lines of the herein described tract, the following courses and distances:
 - a. N 05° 55' 49" E, 60.09' to a 5/8" iron rod with an orange "ALL COUNTY" plastic cap found for angle;
 - b. with the arc of a curve to the right with a radius of 84.78', a central angle of 43° 45' 12", an arc length of 64.74', and a chord which bears N 24° 52' 02" E, 63.18' to a 5/8" iron rod with an orange "ALL COUNTY" plastic cap found for angle;
 - c. with the arc of a curve to the left with a radius of 50.00', a central angle of 53° 07' 06", an arc length of 46.35', and a chord which bears N 78° 22' 52" E, 44.71' to a 5/8" iron rod with an orange "ALL COUNTY" plastic cap found for angle;
 - d. N 56° 36' 37" E, 276.98' to a 5/8" iron rod with an orange "ALL COUNTY" plastic cap found for interior corner;
 - e. N 29° 10' 59" W, 152.82' to a 5/8" iron rod with an orange "ALL COUNTY" plastic cap found for interior corner;
 - f. S 50° 44' 30" W, 173.85' to a 5/8" iron rod with an orange "ALL COUNTY" plastic cap found for corner;
 - g. N 56° 03' 01" W, 109.81' to a 5/8" iron rod with an orange "ALL COUNTY" plastic cap found for interior corner;
 - h. S 46° 30' 08" W, 70.29' to a 5/8" iron rod with an orange "ALL COUNTY" plastic cap found for angle;

- (4) Thence, N 72° 55' 45" W, with the northeast right-of-way line of Country Club Road, the southwest boundary line of the called 194.884 acre tract, the southwest boundary line of the herein described tract, a distance of 50.00' to the POINT OF BEGINNING and containing 10.68 acres of land.
- k. S 63° 53' 36" W, 172.85' to an "X" scribed in concrete in the northeast right-of-way line of Country Club Road, at the west corner of Country Club Estates, Phase 2, and an angle point in the southwest boundary line of the called 194.884 acre tract;
- i. S 45° 48' 49" W, 128.84' to a 5/8" iron rod with an orange "ALL COUNTY" plastic cap found for angle;
- j. S 50° 04' 40" W, 68.00' to a 5/8" iron rod with an orange "ALL COUNTY" plastic cap found for angle;
